# TO BEE OR NOT TO BEE

How to ensure your affidavit is not rejected for incompleteness?

We indicated the need for exempted EME and automatic QSE must complete a BEE affidavit. Completing the affidavit may look easy for some, but we have taken this series to go through the affidavit and what must be completed in each section. Below we look at the BEE affidavit completed by EME – financial sector and have included commentary on what must be completed for each section. Failure to complete the correct affidavit or to complete it incorrectly will deem the affidavit invalid for procurement or tender adjudication.



#### B-BBEE divides companies into three major categories which have covered previously communication:

**Turnover:** Less than R10m per annum



Qualifying Small Enterprises (QSE)

**Turnover:** More than R10m;

less than R50m

## TO BEE OR NOT TO BEE Who is considered to be black in terms of B-BBEE Act.





#### Definition of "Black people"

As per the Broad-Based Black Economic Empowerment Act 53 of 2003 as Amended by Act No 46 of 2013 "Black **People"** is a generic term which means Africans, Coloureds and Indians



who are citizens of the Republic of South Africa by birth or descent; or



who became **citizens** of the Republic of South Africa by **naturalisation** 

- before 27 April 1994: or
- on or after 27 April 1994 and who would have been entitled to acquire citizenship by naturalization prior to that date;



#### Definition of "Black designated groups"

"Black designated groups" means:



**unemployed black people** not attending and not required by law to attend an educational institution and not awaiting admission to an educational institution:

- **Black** people who are **youth** as defined in the National Youth Commission Act of 1996;
- **Black** people who are **persons with disabilities** as defined in the Code of Good Practice on employment of people with disabilities issued under the Employment Equity Act;
- Black people living in rural and under developed areas;

**Black military veterans** who qualifies to be called a military veteran in terms of the Military Veterans Act 18 of 2011:"

#### **Commissioner of Oaths**
